



Story Time at Schoolhouse Learning Center Rates: 2023-24

IMPORTANT:

- All families are required to pay for **every day** of their specified payment period **including holidays and other school closings**.
- Story Time is a full year preschool that includes a summer program. **Summer enrollment is required** unless one has explicit permission from the Preschool Director or Head of School.
- **ACT 166 is Vermont's Universal PreK program that provides FREE additional preschool funding for eligible students, please see more information below!**

ANNUAL TUITION (52 weeks)

Note: If comparing these rates to other preschool's published rates, keep in mind that many schools do not include summer (10 additional weeks) in their calculations. These rates have been adjusted according to our 2023-24 school year length (52 weeks).

If your student is eligible for Act 166, your annual tuition will be reduced by \$3,764.

*This information is provided based on the 4:00 close time on Wednesday each week. There is not a 4:00 pick up option any other day of the week.

Information about Act 166: Universal PreK for 3, 4 and 5 year olds

- Families of students who are age 3,4, or 5 by September 1, 2023 will receive \$3,764 toward the equivalent of 10 hours of preschool for 35 weeks (a typical academic year).
- The length of the Act 166 term (35 weeks) does not change the fact that The Schoolhouse contract requires families to enroll for the full year (52 weeks). You cannot enroll for only 35 weeks.
- You will receive district-specific instructions from our Act 166 coordinator about enrolling in Act 166. Registration requirements vary based upon the school district you live in.
- Parents are responsible for submitting the Act 166 application to the district. Please provide our Act 166 coordinator with a copy of the email that confirms that the district received your enrollment paperwork. ***Parents are responsible for making sure this paperwork is completed in a timely fashion to ensure you receive funds.***

How to calculate your student's annual tuition: 2 options

Option 1:

Option 2:

Use the following chart to manually calculate your tuition

Step 1: Complete the first 4 rows of this chart.

Enter in Column A...	Column A	For each row, multiply column A by the rate and enter in column B	Column B
# of days/week of 1 or 1:30 pick up		Multiply the # in column A by \$3,197 and enter in column B	
# of days/week of 2:45 pm pick up		Multiply the # in column A by \$3,872 and enter in column B	
# of days/week of 4 pm pick up		Multiply the # in column A by \$4,230 and enter in column B	
# of days/week of 5 pm pick up		Multiply the # in column A by \$4,603 and enter in column B	
Step 2: Add up Column B			

Step 3. Calculate your annual tuition as follows:

If your student does NOT qualify for Act 166/Universal PreK funds: Your annual tuition is the number calculated in Step 2.

If your student qualifies for Act 166/Universal PreK funds: Subtract \$3,764 from the figure in Step 2 to find your full year tuition.
